#### STEP 1

Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool.

#### WARNING

YOU WILL BE WORKING AROUND THE ENGINE AND EXHAUST SYSTEM DURING INSTALLATION. ENSURE THAT THE ENGINE AND EXHAUST SYSTEM HAVE FULLY COOLED TO PREVENT INJURY.

#### STEP 2

Refer to PIC 2 and 3. Place the elastic opening of the Pre-Filter/Rain Sock over the front of the Hypercharger ES. Stretch the Pre-Filter over the front and around to the back of the Hypercharger ES.

#### CARE AND USE OF THE PRE-FILTER/RAIN SOCK

- Kuryakyn uses only oiled gauze filters from K&N. These filters remain fully functional and effective in rain and inclement weather.
- The Pre-Filter/Rain Sock can be used:
  - If riding in the rain for extended periods of time
  - To help keep insects and other debris from accumulating on the gauze filter.
  - To reduce exposure of the gauze filter to soapy water or high pressure spray when washing the motorcycle.
  - The Pre-Filter/Rain Sock is made from water repellant and UV resistant fabric.
  - The Pre-Filter/Rain Sock will filter debris down to .005 size particles.
  - The Pre-Filter/Rain Sock should be removed and cleaned with hot soapy water and rinsed with clean water once a month or every 3000 miles if used on a continuous basis.
