**STRICTLY OBSERVE THE FOLLOWING GUIDELINES IN ORDER TO USE THE PRODUCT PROPERLY AND AVOID POTENTIALLY DANGEROUS ACCIDENTS.**

- STEP 1** Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition.
- STEP 2** Remove the stock pegs from the OEM mounts by removing the cotter pin and washer from the bottom of the mounting pin. Watch how the placement of the spring is connected to the peg and the hole in the mount. Keep all these parts, they will be reused.
- STEP 3** Remove the OEM mounts using a hex wrench to remove the 2 bolts. These bolts will not be reused.
- STEP 4** Mount the new bracket into place using the new fasteners. Make sure to apply anti-seize on new fasteners.

**ATTENTION!** Ensure that the supplied anti-seize is applied to all threaded fasteners before installation; this will make future removal of the fasteners easier.

**STEP 5** Reconnect the peg to the new mount while making sure that the spring is in the proper position. Drop mounting pin back into position and secure with washer and cotter pin. Check to make sure that your peg pivots up freely.

**STEP 6** Repeat above steps for other side.

**ATTENTION!** It is the installer's responsibility to ensure that all of the fasteners (including pre-assembled) are tightened before operation of the motorcycle. Kuryakyn will not issue a warranty on components lost due to improper installation. Periodic maintenance may be required.
